A meeting of the Board of Trustees of the Incorporated Village of Head-of-the-Harbor was held on Wednesday, November 20, 2024 at 7 PM at the Village Hall located at 500 North Country Rd., St. James, NY 11780. Those present were the following members Mayor Michael D. Utevsky, Deputy Mayor Lisa Davidson, Trustees Judith C. Ogden, Jeffrey D. Fischer and Trustee Daniel W. White. Also, in attendance Village Administrator/Clerk, Margaret O'Keefe; Police Chief, Charles M. Lohmann; Building Inspector, Robert O'Shea; Village Attorney, Tim Hill. Not in attendance Dir. of Highway Operations, Frank Prinzevalli and Village Treasurer, Patricia Mulderig.

#### Mayor Michael D. Utevsky:

- Mayor Utevsky convened the public hearing on Local Law (Intro) #1 OF 2024, "A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW §3-c." Discussion ensued. There being no further dialogue, the hearing was closed.
- Mayor Utevsky convened the public hearing on Local Law (Intro) #2 OF 2024, "AMENDING CHAPTER 153-3 OF THE CODE OF THE VILLAGE OF HEAD OF THE HARBOR ENTITLED "STOP AND YIELD SIGNS AND MARKED INTERSECTION SIGNS"" Discussion ensued. There being no further dialogue, the hearing was closed.

# **RESOLUTION #110 – 2024 LOCAL LAW TO OVERRIDE THE 2025 TAX CAP LIMIT**

**WHEREAS,** according to New York State's Property Tax Cap legislation, if a Village government decides to adopt a budget with a property tax levy that exceeds the level set by the State, the Village government must pass a local law to override that cap; and

**WHEREAS**, adopting said local law is not predictive of the final tax levy but will provide the Village Board with flexibility to exceed the Property Tax Cap if it is deemed necessary, and to ensure that any State recalculation of the applicable limit will not make the Village inadvertently out of compliance; and

**WHEREAS**, a public hearing was held before the Village Board of Trustees on <u>November 20, 2024</u>, to hear all persons interested in proposed Local Law (Intro) # 1 of 2024,

# NOW THEREFORE, BE IT

**RESOLVED,** that Local Law Filed No. 3 of 2024, a Local Law Authorizing a Property Tax Levy in Excess of the Limit Established in General Municipal Law for 2025 is hereby adopted pursuant to subdivision 5 of the General Municipal Law, Section 3-c, which expressly authorizes the Village Board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent of the Village Board of Trustees; and be it further

**RESOLVED,** that the Village Clerk shall publish, in the official newspaper of the Village, a notice of adoption containing a synopsis of said local law and shall within twenty days file one certified copy in the Office of the County Clerk, and one copy with the Secretary of State.

# VILLAGE OF HEAD OF THE HARBOR LOCAL LAW FILED #3 OF 2024 A LOCAL LAW AUTHORIZING PROPERTY TAX LEVY IN EXCESS OF THE LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW §3-c

Be it enacted by the Village Board if the Village of Head of the Harbor as follows:

# Section 1. Legislative Intent and Purpose

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Village of Head of the Harbor pursuant to General Municipal Law §3-c, and to allow the Village to adopt a budget for the fiscal year beginning March 1, 2025 that requires a real property tax levy in excess of the "tax levy limit" as defined in General Municipal Law §3-c.

# Section 2. Authority

This local law is adopted pursuant to subdivision 5 of the General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax levy limit by the adoption of a local law approved by a vote of at least 60% of said governing body.

## Section 3. Tax Levy Limit Override.

The Village Board of the Village of Head of the Harbor is hereby authorized to adopt a budget for the fiscal year commencing March 1, 2025, that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

## Section 4. Severability.

If any section or subsection, paragraph, clause, phrase, or provision of this law shall be adjudged invalid or held unconstitutional by any court of competent jurisdiction, any judgment made thereby shall not affect the validity of this law as a whole, or any part thereof other than the part or provision so judged to be invalid or unconstitutional.

# Section 5. Repeal.

If the Village Board of Trustees of the Village of Head of the Harbor adopts a budget for the fiscal year commencing March 1, 2025, that does not require a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law § 3-c (to wit, if the authorization contained in Section 3 of this Local Law is not utilized), the override authority under this local law may be repealed by resolution of the Board of Trustees (to wit, without a public hearing and without any further local law).

# Section 6. Effective Date.

This Local Law shall take effect upon adoption.

 It was upon motion by Trustee Fischer, second by Trustee White and voted upon as follows: **RESOLUTION #111 OF 2024** AMENDING CHAPTER 153-3 OF THE CODE OF THE VILLAGE OF HEAD OF THE HARBOR ENTITLED "STOP AND YIELD SIGNS AND MARKED INTERSECTION SIGNS

WHEREAS, the Board of Trustees, after undertaking a review, wishes to improve the safety of the motorists at additional road intersections within the Village, specifically the intersection of: Carman Lane and Cordwood Path (West), Rhododendron Drive and Saddle Road (South), Saddle Road and Rhododendron Drive (East), Deep Wells Lane and North Country Road (North); and

**WHEREAS**, the Village has determined that the installation of "STOP" signs at these intersections is necessary for the health, safety and welfare of the Village, and

WHEREAS, the installation, placement and maintenance of traffic control devices must comply with the New York State Manual of Uniform Traffic Control Devices and Title 17 of the New York Code Rules and Regulations

(Department of Transportation):

NOW, THEREFORE, BE IT RESOLVED, that Local Law No. 4 of 2024 is hereby adopted, amending Village Code Sec. 153-3 Schedule B to add additional stop sign intersections as follows:

Chapter 153. Vehicles and Traffic

§ 153-3. Stop and yield signs and marked intersection signs.

- 9 15-9-5, stop and yere signs and marked micrection signs.
  A. The driver of a motor vehicle that approaches a stop sign shall stop the vehicle at a stop line, but if there is no stop line then at a point near the intersecting roadway where the driver can see traffic on that roadway, without allowing the vehicle to enter the intersection. The driver of a motor vehicle that approaches a yield sign, if required to stop in the interset of safety, shall stop the vehicle at a stop line, but if there is no stop line then at a point near the intersecting roadway where the driver can see traffic on that roadway, without allowing the vehicle to enter the intersection. After stopping, the driver shall proceed in accordance with state rules of the road for rights-of-way.
- B. For the purpose of maintaining an accurate record of all regulations adopted under the provisions of this section, there is hereby established a system of schedules in which shall be entered all regulations after adoption. Such schedules shall be deemed a part of this section. Schedule A. No Left Turn Intersections

C. Notwithstanding any official traffic control signal indication to proceed and excepting the order of a police officer otherwise, a driver of a vehicle shall not enter an intersection unless three is sufficient space on the other side of the intersection to accommodate completely the vehicle driven without obstructing in any manner the through passage of vehicles from either side. In no event shall a driver enter an intersection described in Schedule D below marked by a "Do Not Block Intersection" sign, except while observing the restrictions of this subsection.

#### **RESOLUTION FOR STATE AID (Deemed read into the record)**

• It was, upon motion by Trustee Fischer, second by Trustee White and unanimously adopted: **RESOLUTION #121-24** 

**WHEREAS,** until 2024, cities, villages and towns had not received an increase in unrestricted state aid (AIM funding) in 15 years, significantly impacting their ability to provide essential services to their residents; and

**WHEREAS**, after a prolonged period without financial support, local governments finally received an increase of \$50 million in unrestricted state aid; and

**WHEREAS,** local officials express their gratitude for the \$50 million increase in unrestricted state aid, recognizing it as a positive step towards addressing long-standing funding challenges; and

**WHEREAS**, the State has referred to this new aid as Temporary Municipal Assistance, suggesting that such increase may not continue, jeopardizing the sustainability of crucial municipal programs and services; and

**WHEREAS,** the property tax cap further limits the ability of local governments to properly fund the programs and services their residents need; and

**WHEREAS**, increased and ongoing state aid for local governments is vital for maintaining infrastructure, public safety, housing and other municipal services; and

**WHEREAS**, the challenges of inflation, the increasing costs of labor and supplies, and the end of extraordinary federal aid only accentuate the need for consistent and predictable funding to effectively plan for the future and meet the growing needs of their residents;

**NOW, THEREFORE, BE IT RESOLVED**, that Inc. Village of Head of the Harbor calls upon the Governor and the State Legislature to commit to continuing the additional \$50 million in unrestricted state aid in the 2025-26 State Budget and beyond, and

**BE IT FURTHER RESOLVED**, that Inc. Village of Head of the Harbor urges state officials to recognize the need for a long-term plan that ensures consistent and predictable increases in financial support for local governments that keep pace with inflation.
